Dear Comrades,

An Emergency Executive Committee Meeting was held on 4<sup>th</sup> September, 2022 through Virtual mode. The meeting commenced at 3.00 p.m. Com. T. Sekar, President presided over the meeting. He welcomed all the Office Bearers and the Executive Committee members and spoke on the need for convening this emergency meeting. He requested the General Secretary to proceed with the agenda of the meeting.

**Homage :** Two minutes silence was observed for the demise of Com. N. Boopathi, Treasurer of our Union and Com. M. Ramakrishnan former Vice-President of our Union.

**Co-option of Treasurer :** Com. General Secretary placed the proposal of co-option of Com. R. Sampath, Organising Secretary, Karur as Treasurer of our Union in the place of Com. N. Boopathi who expired recently.

**Co-option of Organising Secretary :** Com.General Secretary also placed the proposal of co-option of Com. G. Ramkumar, Executive Committee Member, Tiruvannamalai as Organising Secretary in the place of Com. R. Sampath.

Executive Committee Members unanimously approved the above proposals and wished both the comrades all success.

**Nomination of Trustee to the KVB Employees PF Trust :** Com.General Secretary placed the proposal of nomination of Com. R. Sampath, Treasurer as Trustee to the KVB Employees' Provident Fund Trust representing Union. Executive Committee Members unanimously accepted the above proposal.

Com. General Secretary reported the developments that took place after our 37<sup>th</sup> conference held in Coimbatore in May 2022. He said that a meeting of the Co-ordination Committee of both KVBEU & KVBOA held last week and in that meeting it was decided to conduct centralized meeting at important centres which will be attended by the members of both the Organisations. Executive Committee Members welcomed this decision and stated that co-ordination must be there not only at the apex level, but at the branches also.

Com.General Secretary informed that our AIBEA had sought suggestions from bank-wise unions and also from the individual members for the preparation of Charter of Demands for the 12<sup>th</sup> Bi-partite Settlement. He requested the office bearers and executive members that any suggestions on the above has to be sent to the union head quarters immediately so that the same can be consolidated and forwarded to our AIBEA.

Issues deliberated by the Committee Members :

- Shortage of Clerks in many branches. Due to this the workload is getting increased and also the working hours get elongated. Management has to immediately commence the process of recruitment of adequate Clerks and post them at the needy branches. Further, as the working hours of the Clerks gets elongated due to increased workload, management has to consider payment of Overtime for the works carried out beyond the working hours.
- Management has to immediately commence the process of recruitment of Sub-staff from the Temporary Employee Panel.
- Concurrent checking : Only in few branches this work is entrusted to external auditors. In other branches, this work is carried out by the Clerks. Already shortage of clerk is witnessed in many branches and this concurrent checking work adds to the workload of the clerks. Further, instructions are now given to the concurrent checking clerks to scan all the vouchers on a daily basis. This again adds to the workload of the concurrent checking clerk.
- Management has to issue detailed circular guidelines on the roles and responsibilities of the Clerks who are holding the second set of safe keys as Joint Custodian.

Com. General Secretary informed that many of the above issues were already taken up with the management and once again it will be taken up with the concerned departments. He also informed that union had already represented to the management for considering payment of Ex-gratia to some of the employees who have not received the same.

Com. President summed up the deliberations and appreciated the office bearers and executive committee members for their active participation on this virtual meeting. He said that all the issues discussed in the meeting would be taken up with the management.

The virtual executive committee meeting concluded by 5.00 p.m.


