**Meeting of AIBEA's Private Sector Bank Unions Cell**

A meeting of the AIBEA's Private Sector Bank Unions Cell was held today in Bengaluru.

At present in 11 private sector Banks, AIBEA has its units and leaders of all these 11 unions were present in the meeting. Com. D R Tuljapurkar, Com S D Srinivasan, Com B Ramprakash, Com. M Jayanath, office bearers of AIBEA and Com. E Arunachalam and Com M S Srinivasan, CC Members of AIBEA participated in the meeting along with the General Secretary of AIBEA.

A report was presented in the meeting covering the activities since our last meeting as well the important problems facing our unions and members in the private sector Banks. All the participants spoke about the present position in their Banks and shared their experiences and viewpoints.

It is a matter of satisfaction that all our Unions in the private sector Banks are functioning effectively despite the odds and difficulties faced by them due to the approach of the management, etc.

After deliberations, the meeting outlined the following important issues and demands to be pursued by us:

- 1. All Private Banks to be brought under Public Sector/nationalised sector**
- 2. Adequate recruitments**
- 3. Permission to have separate Pension Trust for Private Banks**
- 4. Wage revision in CSB Bank**
- 5. Stop sale of IDBI Bank**
- 6. Merge Nainital Bank with Bank of Baroda**
- 7. Extend retirement age in TN Mercantile Bank to 60 years**
- 8. Extend 100% DA in all private Banks covered by BPS**
- 9. Implement ex-gratia to all pensioners of private Banks**
- 10. Pension Option for resigned employees of private Banks**
- 11. Extend 12<sup>th</sup> BPS in Tamilnad Mercantile Bank**
- 12. Withdraw victimisations in Federal Bank**
- 13. Absorption of all temporary employees**
- 14. Organising the contract employees/ C2C employees/Bank**
