Dear Comrades,

Solidarity Strike in Kerala by all Bank employees on 22-10-2021 In support of 3 Days Strike in CSB Bank

While all Banks have agreed and implemented the 11th Bipartite Wage Revision by giving their mandate to IBA, CSB Bank Ltd. (Catholic Syrian Bank) is not agreeing to give wage revision for its employees and officers.

Upto 10th Bipartite Settlement, CSB Bank was part of the industry-level uniform wage revision. Few years ago, the management of this 100 years old Bank (oldest private sector bank in Kerala and founded in 1920) has been passed on to the hands of Fairfax Financial Holdings, a Canada based Investment Company.

This time, they were reluctant to give the mandate to IBA but we were pursuing the issue. We had met the MD of the Bank who assured us that once the health of the Bank improves, they would give the mandate and also implement wage revision.

Wage Settlement has been implemented in all the Bank including all the private Banks. Now, the management says that they will not extend the 11^{th} BPS wage revision to the employees and officers.

On the other hand, the management has also stopped recruitment of staff with IBA wage pattern and is encouraging the appointment of Cost to Company staff in a big way. Out of the total of about 3000 employees and officers of the Bank, 1200 are already C2C staff.

For the past 2 to 3 years, the management was citing the Bank's performance as a reason for not giving mandate to IBA. Now the Bank has made good profits. While the MD/CEO has been awarded Rs. 6 crores for this performance, the management says that the productivity of the employees is low and hence wage revision cannot be given.

In the backdrop of this deliberate attitude of the management, the United Forum of CSB Bank Unions (AIBEA-AIBOC-BEFI-INBEF) had given the call for 3 days strike all over the country on $29^{th}/30^{th}$ September, and 1^{st} October, 2021 which was successfully implemented.

Still the management remains adamant. Hence the United Forum of CSB Bank Unions (AIBEA-AIBOC-BEFI-INBEF) has given the call for **another 3 Days Strike on 20th, 21st and 22nd October, 2021.**

In this background, we have requested all our Unions to extend their support to the struggle in CSB Bank and the ensuing 3 days strike.

Since CSB Bank is predominantly a Kerala based Bank where more than 300 Branches of the Bank's around 450 Branches are located in Kerala, our All Kerala Bank Employees Federation has been in organising solidarity programmes in support of their agitation. Struggle Aid Committee has been formed with the participation of all leading Central Trade Unions like BMS, INTUC, AITUC, CITU, etc. Issue has been raised in the State Assembly and the issue has gone to the attention of the State Finance Minister also.

Looking to the gravity of the situation, AKBEF took the lead and call for **SOLIDARITY STRIKE** has been given by AIBEA, BEFI, INBEF and AIBOC for a **State-level Strike by all other bank employees on 22-10-2021**.

We request all our All India Bankwise Unions/Federations to advice their units/members in Kerala to take part in the Solidarity Strike on 22-10-2021 and make it a massive success.
